## Undergraduate Transfer Evaluation Guidelines

### Bachelor of Science in Business – Information Technology Management

A transcript evaluation is completed once official transcripts from all previously attended institutions have been received by WGU. Please note that transcripts must be sent to WGU directly from the issuing institution to be considered official. WGU does not perform unofficial evaluations or accept unofficial transcripts. The guidelines below will provide a good indication of expected transfer credit. Official transcript evaluations will occur in the month prior to your start. Transcripts are processed in the order they are received. Please contact your Enrollment Counselor if it has been more than 15 business days since your transcripts have been received and you have not received an evaluation. Transfer credit **will not** be awarded for transcripts received after your first term start date. Transfer credit awarded for Business, Information Technology, or Health Professions College programs may not apply if a program change is made to the WGU Teacher's College.

#### COURSES ACCEPTED FOR TRANSFER CREDIT:

- Must be college level from an institution that is recognized as *Nationally or Regionally* accredited by the U.S. Department of Education. *For a list of USDE recognized National and Regional accrediting agencies, see: [CLICK HERE](#)*
- Must have been awarded a grade of C- or better.
- May not be used to fulfill more than one course of study.
- Must meet the competency unit and content equivalency requirements.

#### COURSES SATISFIED BY AN ASSOCIATE OR BACHELOR'S DEGREE:

- Where transfer credit does not apply, courses may receive a Requirement Satisfied (RS).
- Courses that receive a Requirement Satisfied can be fulfilled by an Associate of Arts, Associate of Science, Associate of Applied Science, Bachelor of Arts, or Bachelor of Science from a Regionally or Nationally accredited institution. (Accrediting agency recognized by The U.S. Department of Education)
- In certain cases, the degree must be in a specific field of study.
- Requirement Satisfied by degree does not apply to all courses or programs at WGU. A change in majors at WGU may result in the removal of credit.

<i>Foundations —The requirement below may be satisfied by an Associate or Bachelor's degree.</i>

C463	Intermediate Algebra	3	One course in Intermediate Algebra or higher. *Can be satisfied by an Associate or Bachelor's Degree

<i>Language and Communication - The requirement below may be satisfied by an Associate or Bachelor's degree.</i>			
CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C455	English Composition 1	3	One course in English Composition, equivalent to 3 units. Business Writing cannot be used to satisfy the requirement for English Composition I. *Can be satisfied by an Associate or Bachelor's Degree
C456	English Composition 2	3	A second, sequential course in English Composition, equivalent to 3 units, excluding business writing. *Can be satisfied by an Associate or Bachelor's Degree
C132	Elements of Effective Communication	3	One course in Speech and Communication, equivalent to 3 units. *Can be satisfied by an Associate or Bachelor's Degree

**Quantitative Literacy** – The requirement below may be satisfied by an Associate or Bachelor's degree.

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C278	College Algebra	4	One course, equivalent to 4 units at or above College Algebra level (including Trigonometry, Calculus or Linear Algebra). *Can be satisfied by an Associate or Bachelor's Degree
C459	Introduction to Probability and Statistics	3	One course, equivalent to 3 units in Statistics (if C278 is filled by College Algebra, C459 can only be filled by a course in Statistics), or a course higher than College Algebra in addition to the one accepted for C278. *Can be satisfied by an Associate or Bachelor's Degree

**Humanities** – The requirement below may be satisfied by an Associate (except Associate of Applied Science) or Bachelor's degree.

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C100	Introduction to Humanities	3	One course in the Humanities, equivalent to 3 units (literature, visual and performing arts, music, theatre, philosophy, ethics, or religious studies). *Can be satisfied by an AS, AA, BA, or BS degree. Cannot be filled by an AAS degree.

**Natural Science** – The requirement below may be satisfied by an Associate or Bachelor's degree.

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C451	Integrated Natural Sciences	4	One course, equivalent to 3-4 units, in Life or Physical Science. *Can be satisfied by an Associate or Bachelor's Degree
C452	Integrated Natural Sciences: Applications	4	One course, equivalent to 3-4 units, in Physical or Life Science with a lab component. *Can be satisfied by an Associate or Bachelor's Degree

**Social Science** – The requirement below may be satisfied by an Associate or Bachelor's degree.

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C255	Introduction to Geography	3	One course, equivalent to 3 units, in Geography. *C255 may be satisfied by a course in social sciences (i.e. history, anthropology, sociology, psychology, economics or political science). *Can be satisfied by an Associate or Bachelor's Degree.

**Reasoning and Problem Solving** – The requirement below may be satisfied by an Associate or Bachelor's degree.

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C168	Critical Thinking and Logic	3	One course, equivalent to 3 units, in critical thinking, reasoning, argument or logic. *Can be satisfied by an Associate or Bachelor's Degree

**Business Law and Ethics**

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C713	Business Law	3	One course, equivalent to 3 units, in Business Law. *C713 can be satisfied by an Associate or Bachelor's degree in Business.
C717	Business Ethics	3	One course, equivalent to 3 units, in Business Ethics (not professional ethics or the study of ethics. Course must be focused on Business Ethics). *C717 can be satisfied by an Associate or Bachelor's degree in Business.
C711	Introduction to Business	3	One course, equivalent to 3 units, in Introduction to Business. *Can also be met by an Associates or Bachelor's degree in Business. *Cannot be met with an Associate of Applied Science.

**Organizational Behavior and Management Principles**

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C483	Principles of Management	4	One course, equivalent to 4 units, in management or leadership principles. *Can be satisfied by an Associate or Bachelor's degree in Business.
C715	Organizational Behavior	3	One upper division course, equivalent to 3 units or more in Organizational Behavior. *C715 can be satisfied by an Associate or Bachelor's degree in Business.

### Accounting and Information Technology

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
VYC1	Principles of Accounting	4	One course, equivalent to 3 units, in Accounting Principles I, Financial Accounting I or Intermediate Accounting I. Course must be based upon Financial Accounting principles for transfer credit.
UFC1	Managerial Accounting	3	One course, equivalent to 3 units, in Managerial Accounting or Cost Accounting. Course must be based upon Managerial Accounting principles for transfer credit.
C724	Information Systems Management	3	One course, equivalent to 3 units, in Information Systems Management. Course must cover how businesses use computers to: solve business problems, create strategic advantage and help organizational decision makers. May not be satisfied with a computer literacy course or a productivity software course (such as Microsoft Office). <i>*Courses must be completed within the past 10 years to qualify for transfer.</i>
C708	Principles of Finance	3	One course, equivalent to 3 units, in Business Finance. Cannot be satisfied by Personal Finance or General Finance.

### Marketing Principles and Business Communication

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C712	Marketing Fundamentals	3	One course, equivalent to 3 units in Marketing Fundamentals. <i>* Can also be met by an Associates or Bachelor's degree in Business</i>
VZT1	Marketing Applications	3	One course, equivalent to 3 units, in Marketing Principles. The course description or syllabus must clearly show that a Marketing plan was a requirement of the class. <i>* C712 must be transferred before this requirement can be met.</i>
C716	Business Communication	3	One course, equivalent to 3 units, in Business Communication, with an emphasis in business writing. <i>*Cannot be met with an Associate of Applied Science.</i>

### Economics, Global and Quantitative Analysis for Business

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C723	Quantitative Analysis for Business	3	One course, equivalent to 3 units, from the following options: Quantitative Analysis for Business, Management Science, Decision Analysis, Operations Management, or Business Statistics.
C718	Microeconomics	3	One course, equivalent to 3 units, in Microeconomics.
C719	Macroeconomics	3	One course, equivalent to 3 units, in Macroeconomics.
FVC1	Global Business	3	One course, equivalent to 3 units, in Global or International Business.

### Human Resource Management

*All Certifications must have been completed or renewed within the past 5 years to be considered for transfer.*

CODE	ASSESSMENT	CU	REQUIREMENT FOR TRANSFER
C232	Introduction to Human Resources	3	One course, equivalent to 3 units, in Human Resource Management. May be transferred if a student holds a valid PHR, SPHR or GPHR certification from the HR Certification Institute (HRCI).
C234	Workforce Planning: Recruitment and Selection	3	One course, equivalent to 3 units, in Workforce Planning with an emphasis in operational and strategic planning. May also be transferred if a student holds a valid PHR, SPHR, or GPHR certification from the HR Certification Institute (HRCI).

*\*Note that all IT certifications, degrees or courses must have been completed within five years of start date or as determined valid by certifying vendor, whichever is less.*

C172	Network and Security - Foundations	3	<p>One course in Networking or one of the following Certifications: CompTIA Network+ , CompTIA Security+, MCSE (2003), MCSA (2003), MCSA (Server 2008/2012), MCITP Enterprise Administrator, MCITP Server Administrator, MTA: Networking Fundamentals (98-366), CCENT, CCDA, CCIE, CCNA, CCNA: Voice, CCNA:Wireless, CCNA:Security, CCDP, CCIP, CCNP, CCNP: Security, CCNP: Voice, CompTIA DHTI+, CompTIA Convergence +, Oracle Sun Certified Network Administrator (SCNA), Sun Certified Systems Administrator (SCSA), Sun Certified System Administrator for Sun Cluster 3.2, Oracle Linux Administrator.</p> <p>*Course can be satisfied by an associates or bachelor's degree in Information Technology.</p>
C182	Introduction to IT	4	<p>One course, equivalent to 4 units, in Introduction to IT.</p> <p>*Course can be satisfied by an associates or bachelor's degree in Information Technology.</p>
C179	Business of IT - Applications	4	<p>Can be satisfied by a Business of IT Applications course, equivalent to 3 units. Information Systems Management may not be transferred unless a course for Information Systems Management is presented and accepted for transfer credit.</p> <p>*Course can be satisfied by an associates or bachelor's degree in Information Technology.</p>
C722	Project Management	3	<p>Can be satisfied by any of the following certificates, received or renewed in the last five years: CompTIA Project+, PMP, CAPM, MS 70-633, MCTS Enterprise Project Management, or can be satisfied by 3 or more credit hours in Project Management.</p>
